SUBJECT

Action on Resignation of Senior Advisory Commissioner, Declare a Vacancy on the Senior Advisory Commission, and Set Process for Filling the Vacancy

Council Pillar

Enhance Community Engagement and Transparency

BACKGROUND

On July 16, 2021, Ana Segovia submitted the attached resignation from the Senior Advisory Commission effective immediately. Therefore, creating one vacancy on the Commission for a partial-term ending June 30, 2023.

On May 27, 2021 the Council conducted interviews for the Senior Advisory Commission and established an eligibility list from those interviewed which is to expire six months from that date. The council voted and approved to place Suresh Lokiah and Jim Hohenshelt on that list and invite them back to re-interview should a vacancy occur within that timeframe. Staff reached out to both applicants to inquire if there was still an interest to serve on the commission. Both applicants expressed an interest to continue in the process of being re-interviewed.

DISCUSSION

Accept resignation submitted by Commissioner Ana Segovia and declare the vacancy on the Senior Advisory Commission for a partial-term ending June 30, 2023. Invite both applicants on the eligibility list Jim Hohenshelt, and Suresh Lokiah back and schedule interviews.
