SUBJECT

Recognition of FIRST LEGO League Team "Cats Love Mars"

BACKGROUND

Team Cats Love Mars is an all-girls robotic team made up of students from Central Park Elementary School and Millikin Basics+ Elementary School. Team Cats Love Mars competed in the FIRST LEGO League Global Innovation Championship held on June 30-July 2, 2019, at the California Theatre in San Jose, California. The FIRST LEGO League Global Innovation Championship showcases the real -world, innovative solutions that the FIRST LEGO League teams create as a result of their project. The annual competition encourages teams to develop innovative solutions for real-world problems that demonstrate originality and have the potential to add significant value to the world.

After seeing the devasting effects of the Camp Fire in Paradise, California, the team sought out to create a solution that prevents fires using detection and monitoring. Their invention, Combustion Artificial Intelligence Thermal Imaging Safety System (C.A.T.S.S.), can detect fires, pre-ignition smoldering, hot spots, cool flames, and leaks on the International Space System (ISS) using radiation sensor thermal cameras and machine learning. With their innovative invention, Team Cats Love Mars was selected as one of the 20 semi-finalists in the world for the FIRST LEGO League Global Innovation Award.

DISCUSSION

As a Special Order of Business, the Mayor and Council invited Team Cats Love Mars to share about their invention, C.A.T.S.S. In recognition for inventing C.A.T.S.S and for being selected as one of the 2019 First LEGO League Global Innovation Award Semi-Finalists, the Mayor and Council will present a Certificate of Special Mayoral Recognition to Team Cats Love Mars.
